Eligibility Requirements

In order to enroll in **on campus**, **at high school** or **online** dual enrollment courses, students must meet the following requirements:

- Be a student enrolled in a partner Florida public, charter or private school or home school course of study that fulfills requirements for high school graduation.
- · Have a 3.0 unweighted high school GPA
- Meet alternative initial eligibility criteria indicators that align to Florida Department of Education decreed Executive Order 2020-E0-02*. (Alternative initial criteria applicable through Fall 2020; to request criteria indicators, email dualenro@fiu.edu)
- Home education students must provide proof of enrollment in home education program and be registered with M-DCPS' or Broward Home School Office.
- Meet any additional criteria set by FIU as the post-secondary institution.

Students interested in the **Full-Time/Dual Enrollment Early Admission** program must meet the following requirements:

- Be a rising senior in a school or organization which has an Articulation Agreement with FIU for Dual Enrollment
- · Have a minimum 3.5 unweighted high school GPA
- Have approval from a high school counselor or home school liaison
- Meet alternative initial eligibility criteria indicators that align to Florida Department of Education decreed Executive Order 2020-EO-02 (Alternative initial criteria applicable through Fall 2020; to request criteria indicators email dualenro@fiu.edu)
- Home education students must provide proof of enrollment in home education program and be registered with M-DCPS' or Broward Home School Office.

*In addition, students must be able to provide official academic transcripts, a letter of recommendation and/or test scores in order to schedule an interview.

Additionally, students must meet required testing standards for enrollment in courses with pre-requisites and discipline-specific placement (i.e. ALEKS Math Skills Assessment).

Continued participation in the program requires that students maintain a 3.0 unweighted high school academic work and earn a 3.0 or better in college-level work.

Future admission to FIU as a degree-seeking student is selective and is not guaranteed via participation in the Dual Enrollment Program.

Prospective students must apply to FIU and meet all FIU admissions requirements.

Fall 2020

Recognizing the impact on students and their ability to sit for placement testing, the Florida Department of Education has issued **FDOE Emergency Order 2020-EO-02**dated May 13, 2020,

The order suspends the testing requirement for student eligibility for initial enrollment in college credit dual enrollment courses through December 31, 2020.

Students must still meet the minimum grade point average and course level assessment requirements.

Initial Eligibility

Indicator that applies for Spring 2021:

Meet minimum score on a common placement test adopted by the Florida State Board of Education which indicates that the student is ready for college-level work.

Continued Eligibility

Mandates maintaining a 3.0 unweighted high school GPA and earning and maintaining a 3.0 FIU GPA.

Academic Waiver & FIU GPA Exception

Academic waiver:

- available for enrollment in At-HS campus courses
- not available for enrollment in Online or On-FIU campus courses
- extended to students with unweighted HS GPA between 2.7 and 2.99
- reported by school POI, Person of Interest, when completing eligibility requirement verification and requires the completion of a Waiver form

FIU GPA Exception:

 applied when student FIU Cumm GPA is below 3.0 after earning grade as a first-time dual enrollment student

On-FIU Campus PT DE Enrollment Steps

Student

Step 1: Start Your Application (Online) Returning Students (only if 3 or more consecutive semesters since last application)

Step 2: Required Forms

DE Coordinator/Counselor

Step 1: Verify student Initial or Continued eligibility to enroll in approved DE courses. If student does not meet eligibility requirements, counselor must notify student.

Step 2: Review with student course selection. Courses indicated must be listed as dual enrollment approved courses.

Step 3: Sign and Upload the DE Authorization Form

Students cannot Register for Classes until documents have been uploaded to Sharepoint and registration window opens.

- DE Office completes student registration

FIU Online Dual Enrollment (DE) Facilitator Roles and Responsibilities Commitment Letter

Facilitator Minimum Qualifications and Requirements

- Must be school faculty or staff member, appointed by the school principal or school
- Must clear Level II Background Check
- ✓ Excellent organizational skills
- Strong communication skills
- ✓ Functional knowledge of Microsoft Office Suite
- Attendance to professional development workshop
- ✓ Completion of Canvas training
- Experience in actively coaching students and/or instruct

Facilitator Responsibilities

Before the start of classes:

- Attend the annual professional development (PD) workshop for Facilitators provided by the FIU Dual Enrollment (DE) office, prior to facilitating a course.
- Complete the Canvas tutorial(s) for Facilitators.
- Complete all student Canvas tutorials and trainings.
- ☐ Know the ADD/DROP deadlines and communicate it to students
- Verify that your access to Canvas allows you to view the course content, student's progress and grades.
- Discuss high school class meeting dates with FIU Professor, and, if possible, request that exam dates and deadlines coincide with those dates. Also discuss any school site activities that may conflict with class meeting dates.
- Review the syllabus for any group projects/assignments. Ensure that FIU Professor groups students from the same high school site by class periods.
- Verify that for group projects/ assignments you have all instructional materials. Books should be picked up when you attend the DE PD before the start of the semester.


FT/Dual Enrollment Early Admission 21-22 Apply Steps

- Student emails official academic transcripts, letter of recommendation and test scores to Dual Enrollment Office for verification of eligibility.
- If student meets eligibility requirements, interview will be scheduled. Interviews are conducted during <u>March 1 through April 15, 2021.</u>
- April 30, 2021 Letter of Admission/Denial sent to applicants.
